**Anti Bullying Policy**

**2017-2019**

Bullying is a reality and the staff of Shakespeare Primary School understand the importance of acknowledging this.

We regard bullying as particularly serious and always take firm action against it.

We encourage parents to foster respect for others in their children.

We encourage children to work against it and to report any incidents of bullying.

Shakespeare Primary School's definition of bullying:-

- Deliberately hurtful behaviour.
- Any behaviour where a person with more power uses that power to hurt a person with less power.
- The behaviour has to happen on more than one occasion to be bullying.

**Incidents of bullying can include:-**

Threats of violence

Teasing

Sexist behaviour

Taking belongings

Spreading nasty stories

Mimicking

Disrupting games in the playground

Name-calling

Physically violent acts

Demanding money or materials by force

Ignoring

Racist behaviour

Ridiculing

A group of pupils picking on an individual

Damaging property of others

## **STAFF PROCEDURE FOR DEALING WITH REPORTED INCIDENTS OF BULLYING.**

### **1. BE AVAILABLE**

Break the code of secrecy. Make it known that you are ready to listen. Provide immediate support.

“You have the right to come to this school and feel safe and happy. Tell me what has been happening to you”

### **2. INVESTIGATE**

Investigate every incident as soon as possible; interview all parties individually at first to avoid intimidation and to produce an accurate report.

"I've heard that Paul has been feeling scared and unhappy recently. What do you have to say about that?"

### 3. **RECORD**

Record every incident on the school's Behaviour Database form with specific written reference to actual bullying behaviour and keep other written evidence. Lunchtime supervisors will record any incidents of unacceptable behaviour in writing.

### 4. **VERBALLY RESPOND**

Children to be referred back to the school behaviour and discipline policy (i.e. "to show respect to school staff, parents/carers and each other"), and reminded of the school aims.

"Our school rules encourage us to show respect for each other, and everyone has a right to feel safe and secure in our school environment."

### 5. **FOLLOW UP**

Show that you have a committed position on bullying by following up an incident at a pre-arranged time. This will show both parties that the school supports them and wants to encourage positive behaviour.

"Perhaps we can all meet together this time next week and see how things have been going"

### **ADDITIONAL PROCEDURE**

Serious or excessively persistent bullying, or any evidence of "gang" intimidation, will be referred to the P.S.H.E Co-ordinator, Deputy Head Teacher or Head Teacher.

As with any serious or persistent misbehaviour the parents will be informed. Parents of both parties will be invited to school to discuss the situation individually, in the first instance.

### **WHOLE SCHOOL STRATEGIES TO REDUCE BULLYING BEHAVIOUR**

1. Home-School agreement reinforcing expectations and support between school, parents/carers and child.
2. Lunchtime supervisor training on how to respond to and record incidents.
3. Raising awareness of bullying and offer practical strategies for dealing with it through the use of video and pack 'Stop the Bully Now'.
4. Use of circle time in all year groups to:-
  - a) develop self-esteem and confidence
  - b) promote positive relationships with others, respecting the differences between people
  - c) develop effective skills of co-operation and communication.

Anti Bullying will be a regular theme for our assemblies to highlight its importance.
